
Mike Sheen

COMMITTEE REPORTS

FINANCE:

Treasurer's Report: Submitted by Frank McConnell

September 30, 2011

As of August 31, 2011 the Trust had on hand \$117,285 in unrestricted funds and \$147,334 in restricted Hassel Island funds, for a total of \$264,902, up from \$113,000 as of September 30, 2010. This increase was largely due to the efforts of the fundraising committee headed by Filippo Cassinelli (see separate report). Net income for the Trust (excluding Hassel Island) was \$11,531 as of August 31.

The budget for 2012 (separate document) shows a projected net loss of approximately \$21,000 in the general (non-HI) fund due primarily to decreases in donations and gala income and increases in provisions for the step street project (\$8,500) and a possible move of the office and museum to a new location (\$11,000). We hope that the former can be covered, at least in part, by a grant and the latter may not be necessary. In any event, we have sufficient funds available to cover the projected shortfall.

During 2011 routine bookkeeping and reporting were handled by Kathy Gibson's office. As of October 1 we will be doing these functions in house with the assistance of an independent bookkeeper.

The Finance Committee consisted of Susan Anderson, Joanne Bozzuto, Ray Szymanski, Trevor Milner and Frank McConnell. Trevor resigned from the committee in March to move to Cambodia.

FUND RAISING:

The 2010 annual Gala Dinner was a great success. Net revenue after expenses was \$40,954. Despite the challenging economic environment, we are hopeful that the revenue for the 2011 Gala will be in line with the prior year.

In February, I co- hosted a fund raising dinner at my home with Charles Consolvo who gave a wonderful slide presentation on the historic treasures located on Hassel Island. The guests loved the evening and gave generously. \$17,250 was raised for the general fund. This event has been rescheduled again for February with the same revenue goal.

The Trust secured a number of Grants including \$20,000 from the National Park, \$27,000 from Diageo, \$25,000 from the Vento Foundation, \$5000 from Filippo Cassinelli, and \$1000 from Charles Consolvo. The funds are being used exclusively to cut walking trails linking the historic sites on Hassel Island. Under the direction of the National Park, interpretive signs will be placed on the paths to guide visitors along the trails. A grant for \$5000 was received from the Virgin Islands Council of the Arts and was used to produce a walking tour booklet of the Town of Charlotte Amalie.

The community has been very generous this year in supporting the Trust in its mission of opening the Hassel Island National Park to visitors and residents to enjoy. The following is a list of major donors to the Trust:

LICENSE PLATE PROGRAM:

First let me thank the public for its continued support of the Historical Trust.

Our License Plate Program is only a small part of the Trust in helping to sustain various projects throughout the island. Your donations to the Trust along with the sales of personalized plates go a long way towards preserving and restoring our island treasures.

Personalized plates or numbered plates can be ordered from Rodriquez Auto, who accounts for most of our sales; along with other outlets such as Captain's Corner, which is owned by Mr. Charles Consolvo, who heads the Hassel Island project with great passion; The Virgin Islands State Historic Preservation Office; and lastly our very own Main Office by the Roosevelt Park.

The attention and word of mouth has grossed over \$5000.00 this year. Presently, we feel the low cost of the plates are the main attraction. The numbered plates are \$45.00 for Trust members and \$50.00 for non-members, plus \$6.00 for shipping and handling. Personalized Plates consist of seven characters and numbers only, and run \$90.00 for Trust members and \$100.00 for non-members, plus \$6.00 for shipping and handling. Purchases can be obtained as a souvenir or as a registered plate through the Department of Motor Vehicles to be placed on your car.

EDUCATION OUTREACH:

The way to a student's heart is through art. Especially when the subject is history and historical preservation. That is the approach of the Trust's Art Project Sub-Committee of the Education Outreach Committee, which had a successful year highlighted by an exhibit by CAHS students.

The work of ten Charlotte Amalie High School (CAHS) Advanced Placement Art students were featured in a special exhibit at Scotiabank's Havensight branch. Entitled "Back In The Day", the exhibit was held in June.

The show was a culmination of a semester-long project fostered by the St. Thomas Historical Trust and directed by Susan Edwards, chairman of the art department at CAHS. Elements of the multi-pronged program, designed to teach functional aspects of art and promote appreciation of history, were made possible by the Virgin Islands Council on the Arts, who also matted and framed the paintings via a grant. Scotiabank came to the table to provide a main-stream venue and assistance in hosting the gallery display.

The drawings were inspired by a couple of factors. One was Charlotte Amalie "history-scapes" that they encountered during a tour of Kongens and Kronprindens Quarters conducted by Trust Board member, Felipe Ayala. Another inspiration came from antique post cards shared by local history enthusiast, Jane Sheen.

The project has also brought an understanding of some of the business aspects of the art industry. "The long-term objective of the project was to foster an appreciation for the history and unique culture of St. Thomas beyond the Carnival experience," art teacher Susan Edwards said. "In the short term they learned to apply their skills to a project with a deadline, from drawing to framing to hanging a show."

The Trust hopes to continue this program in the coming year.

This has been a busy and fruitful year for the Hassel Island Task Force. A cultural landscape plan for Creque Marine Railway has been completed by our intern, Sarah Dylla and forwarded to the Virgin Islands National Park Service (VINPS). Contracts have been let for the construction of the roof for the iron cistern at Creque Marine Railway, which is now functional, and a fence around the Head House, thanks to the architectural efforts of John Woods. Preservation of the machinery from the Creque machine shop has commenced. With the cooperation of: Ken Wild (Archaeologist for VINPS); Alan Wentworth (trail clearing); Jeff Chabot (trail construction specialist); and Sarah Dylla, (graphic design); the trail system linking most of the historical sites has been undertaken, including signage and collection and curation of artifacts. On November 19, 2011 a grand trail opening ceremony is planned, to introduce the trails to the public and to thank our major donors who are making it possible, Diageo VI, the Vento Foundation and the National Park Foundation.

The stabilization survey of Prince Frederik's Battery conducted by the Trust with a grant from the American Battlefield Protection Program of the National Park Service has been completed in draft and is awaiting final approval.

We hope to be able to begin tours of the three historic sites owned by the Virgin Islands government, the Garrison House, Prince Frederik's Battery and Cowell's Battery in December of this year, followed by opening all of the sites to tours and exploration by the end of 2012.

None of this would have been possible without the significant fund-raising efforts of Filippo Cassinelli, our Fund Raising Chairman, the enthusiastic response from our community of supporters in the private sector and the support of the office of the Governor.

FORT CHRISTIAN:

The past year has been "quietly" busy for the newly-formed Fort Christian Task Force of the St. Thomas Historical Trust. With a working relationship firmly established with Lorna Thomas, Director of the State Historical Preservation Office (VISHPO) and her team and Daryl Smalls, Commissioner of Public Works Dept. (PWD), considerable progress has been made as evidenced by pictures and media coverage.

The light is getting brighter at the end of the tunnel with the goal of a partial re-opening of "Fort Chris" to the public being within reach. Any re-opening in the near future will be partial with the restoration work in progress but just enough to browse carefully and take pictures of the inside in a manner similar to other major restoration projects of such icons, i.e. El Moro in San Juan.

North and south grounds of the Fort are now fully accessible to the public for touching, feeling and taking pictures of the Grande Dame. Fences have been removed with the exception of the construction staging area on the East side. Bollards have been installed to restrict vehicles. The interior courtyard remains off limits.

Fort Chris looks its age: sporting beauty, rich history and legend. It's extremely picturesque and photogenic in its current state. It is important to note that the Trust's role is strictly supportive. The approach remains a collaborative process to help get the Fort open, which is what everybody wants.

The government's stabilization and restoration project began in 2005 and was to end a year later. The process remains politically and legally delicate as the project remains in litigation. Steve continues to work the program personally, lending help in managing crews and arranging for donations of material as needed. Public Works and associated road crews have been amazing: attacking the work with passion and pride in a diligent, professional manner. They worked at blazing speed to get the initial interim beautification completed. The Governor and his team, including the Director Thomas and Commissioner Smalls are to be commended in taking this initial step.

This kind of work, however, would not have been possible without the moral support and philanthropic commitment to contributing material to the Trust's Fort project by MSI Building Supplies and Sea Chest. Kudos also go to Frank's Lock & Key for their assistance as well.

My Brothers Workshop, the non-profit construction-mentoring program, has been engaged to remove beams, steel scaffolding and other material that they may keep and use for their projects.

The Trust remains optimistic that the Fort that once served as the jail will be completely freed. Look for the restored iconic tower clock to be turned on soon. The time has come for all of us to pay attention to such iconic properties, particularly those we own.
