NAVY GOING TO ST. THOMAS.

Great Demonstration Talked Of
When Danish Isles Are Taken Over.

WASHINGTON, Dec. 26.—Plans for a great naval demonstration to signalize American acquisition of the Danish West Indies are being considered by State and Navy Department officials. Probably the entire Atlantic fleet will be ordered to St. Thomas, the long sought naval base, to participate in the celebration.

Minister Brun of Denmark formally advised the State Department today that the treaty for the sale of the islands had been approved by King Christian, and would be dispatched from Copenhagen on Dec. 30. It should reach here two weeks later for Secretary Lansing's signature.

The Atlantic fleet will mobilize at Guantanamo, Cuba, for Winter manoeuvres next month, and will be reviewed there by Assistant Secretary Roosevelt. Mr. Roosevelt, who will be on his way to inspect the naval forces in Haiti and San Domingo, may take charge of the ceremonies at St. Thomas.

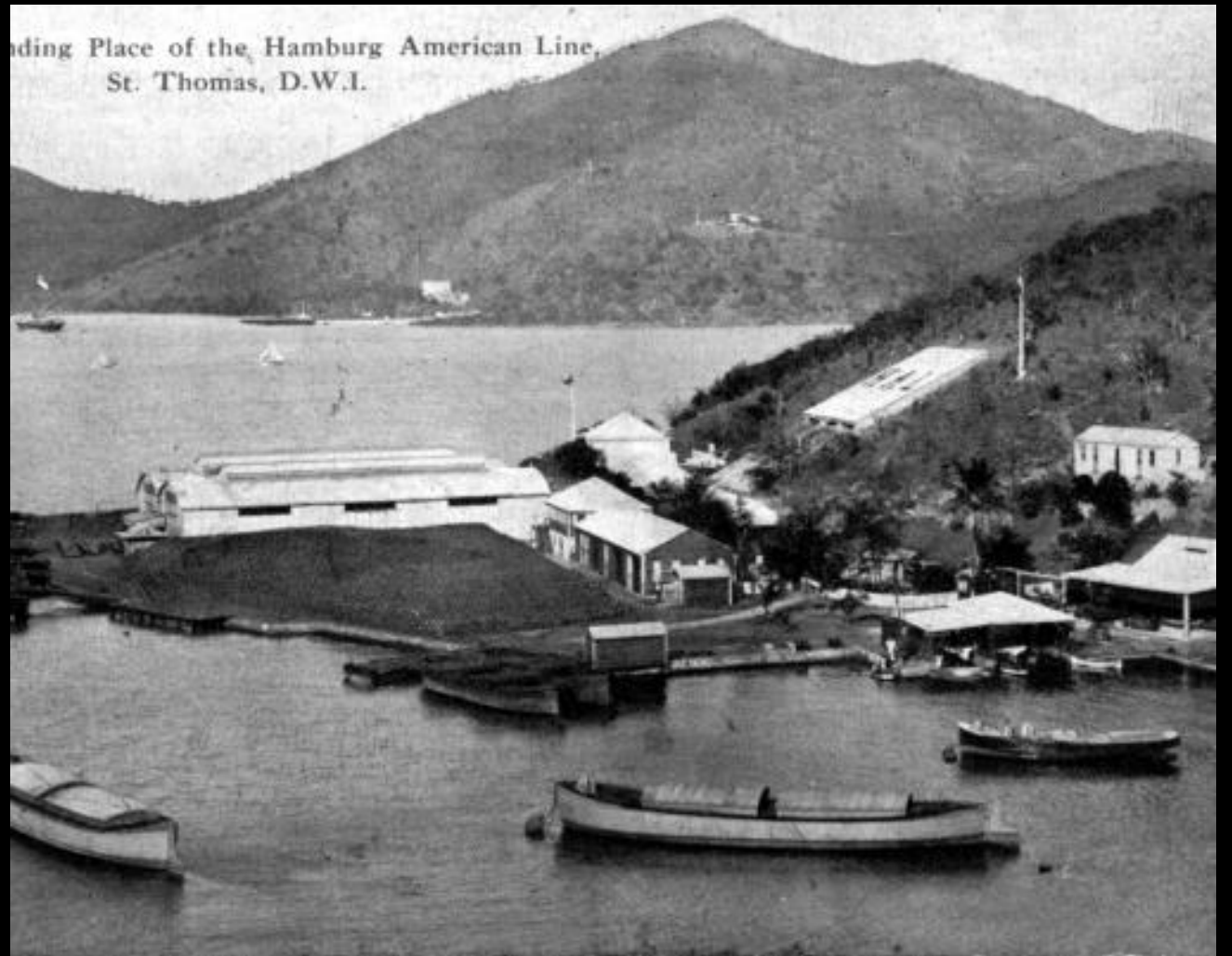

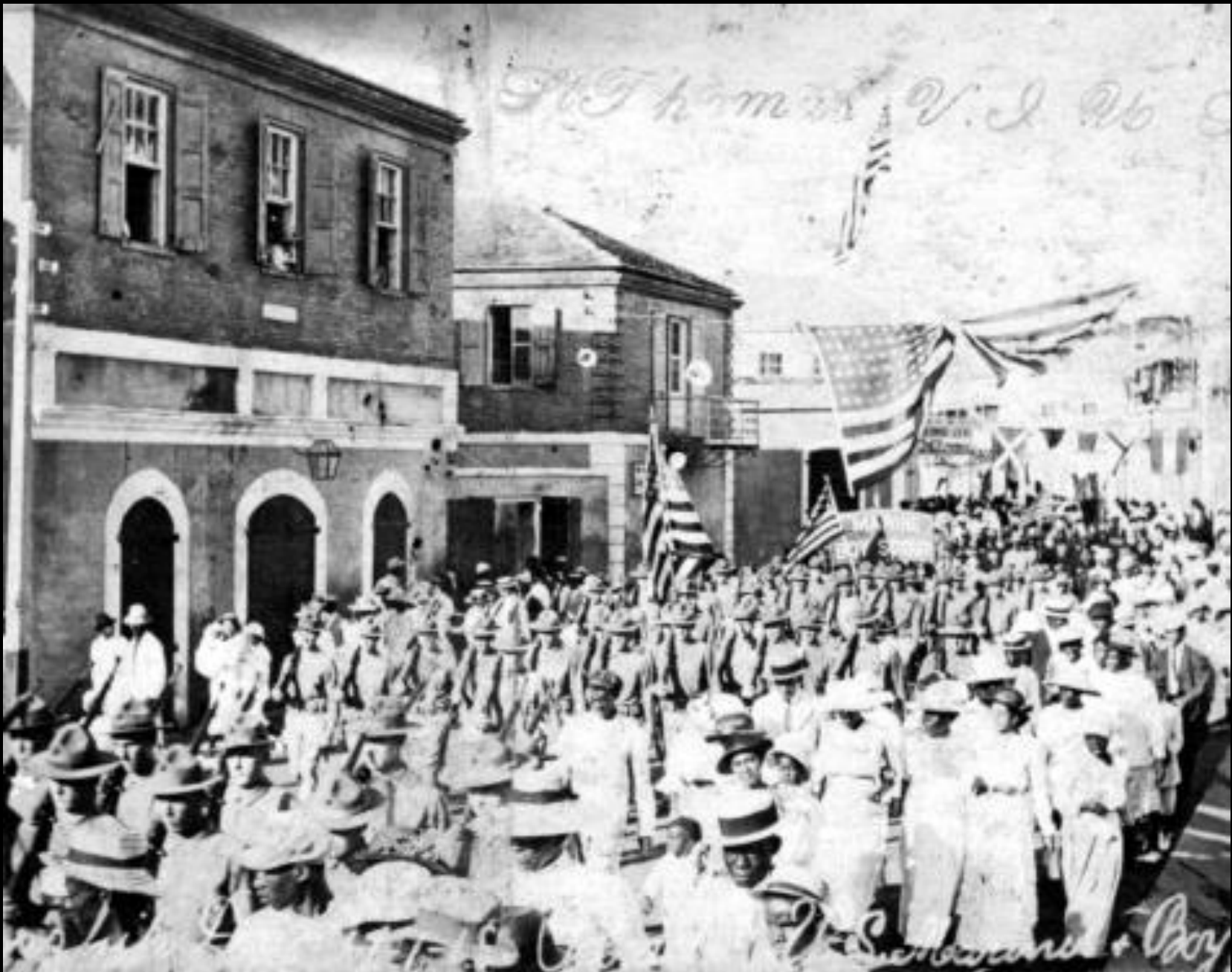

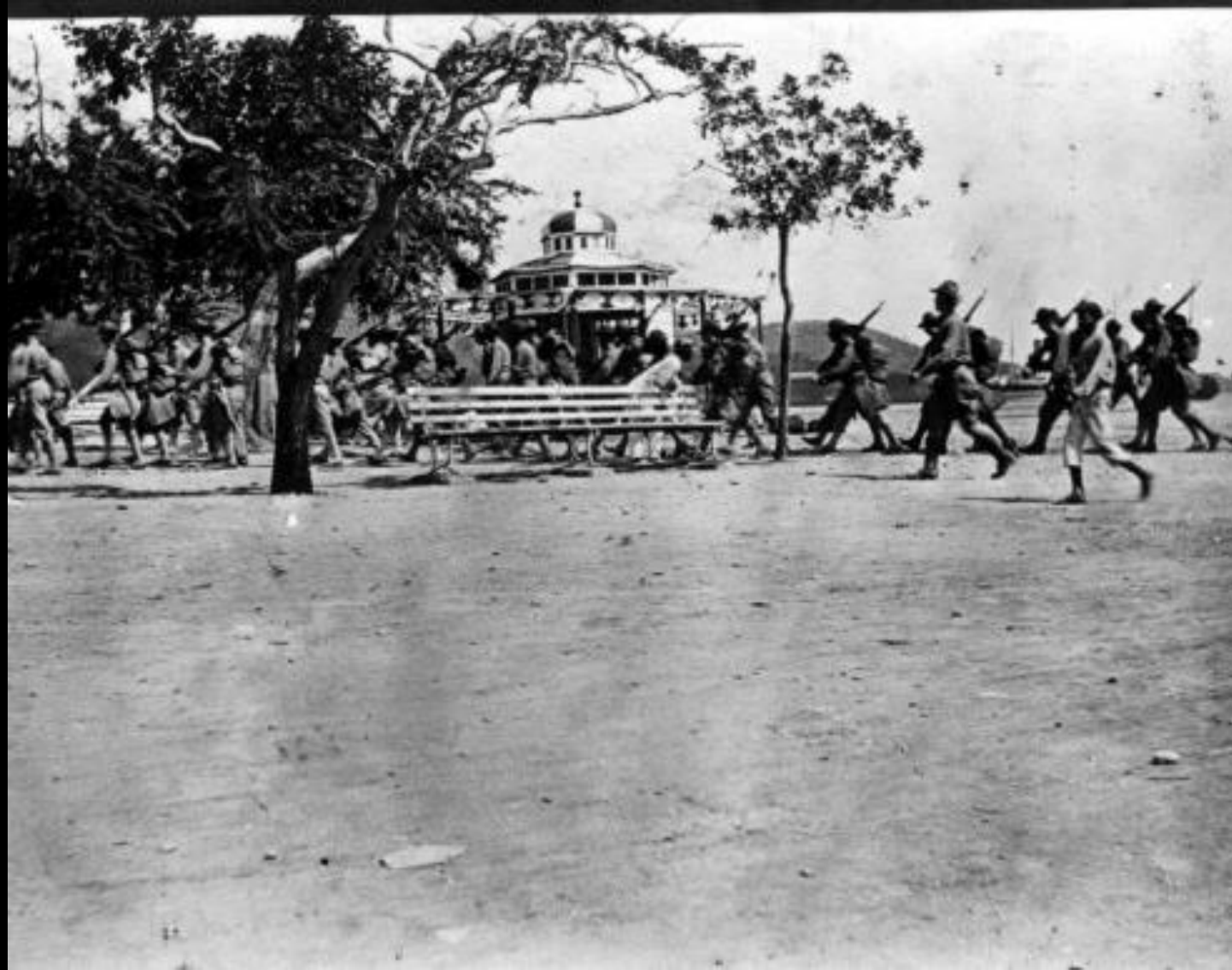

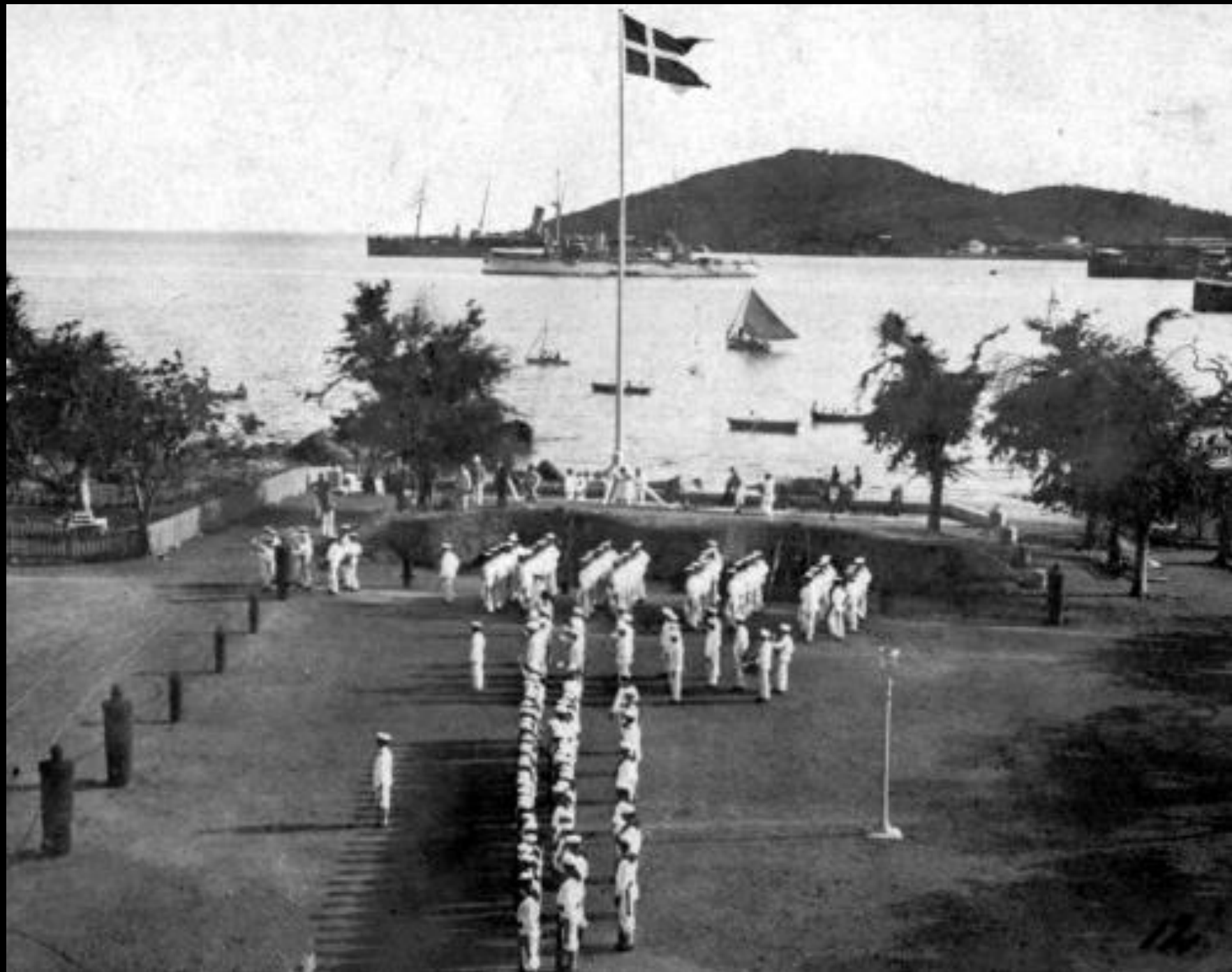

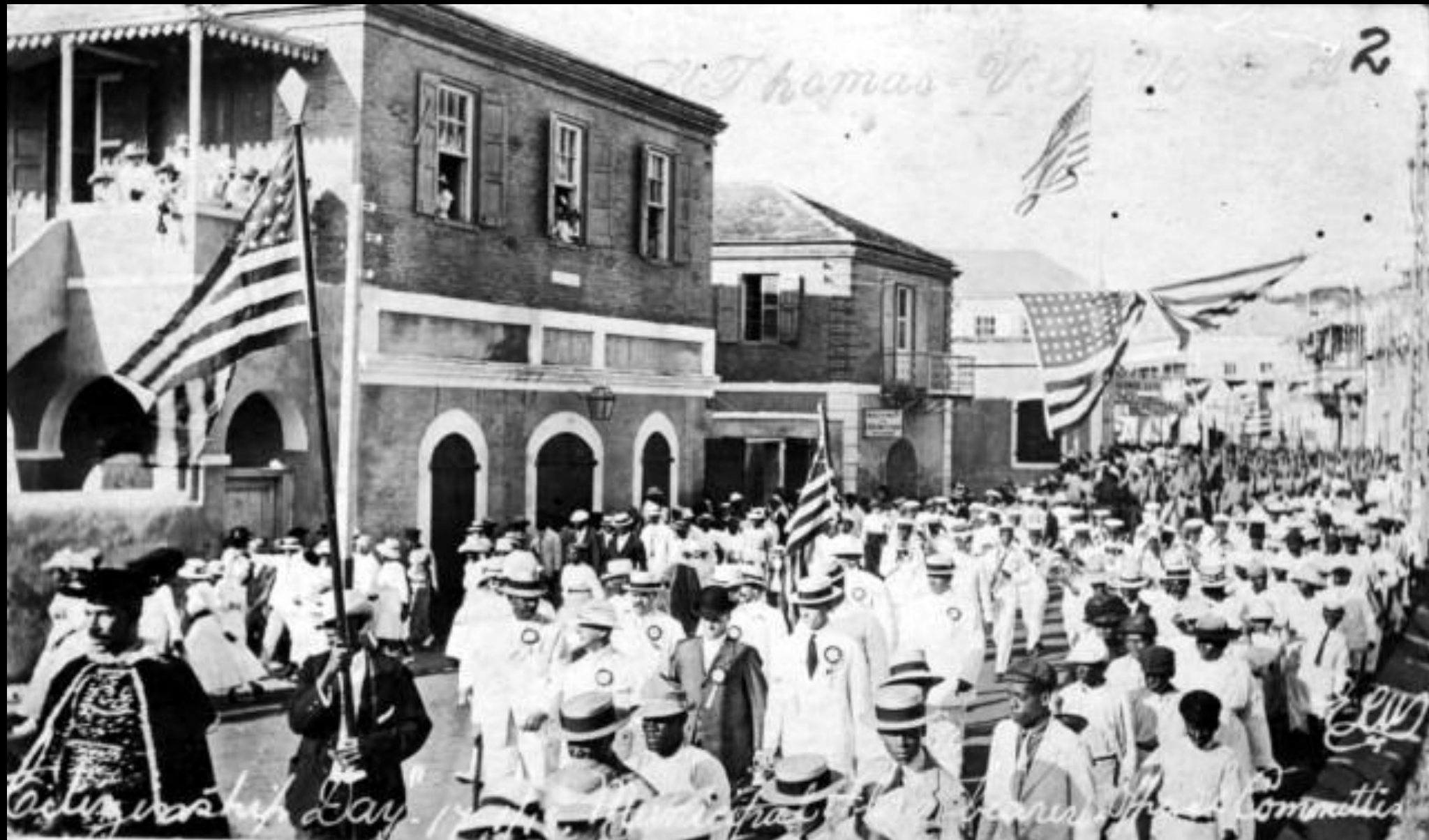

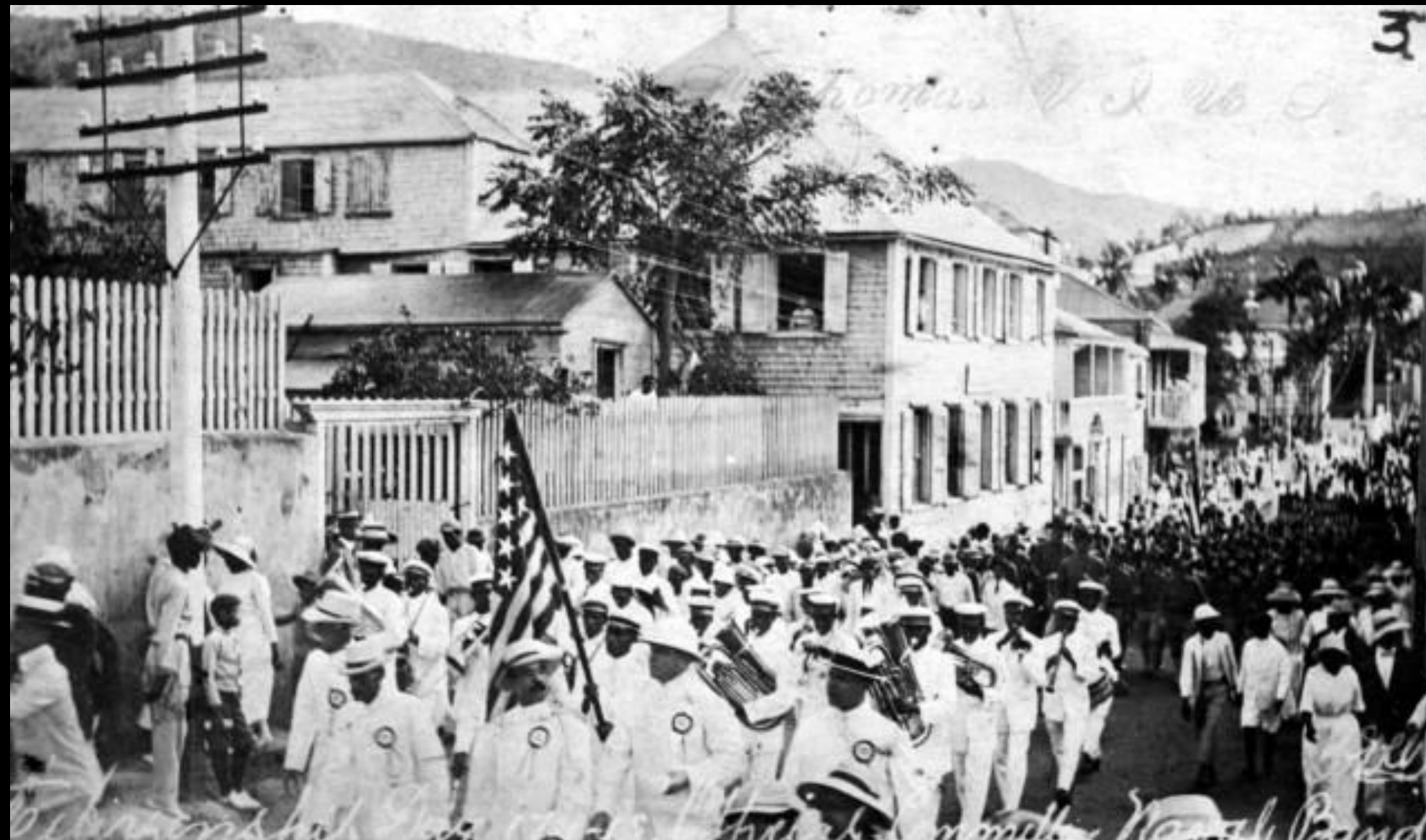

No. 5 (Official Committees) in Center

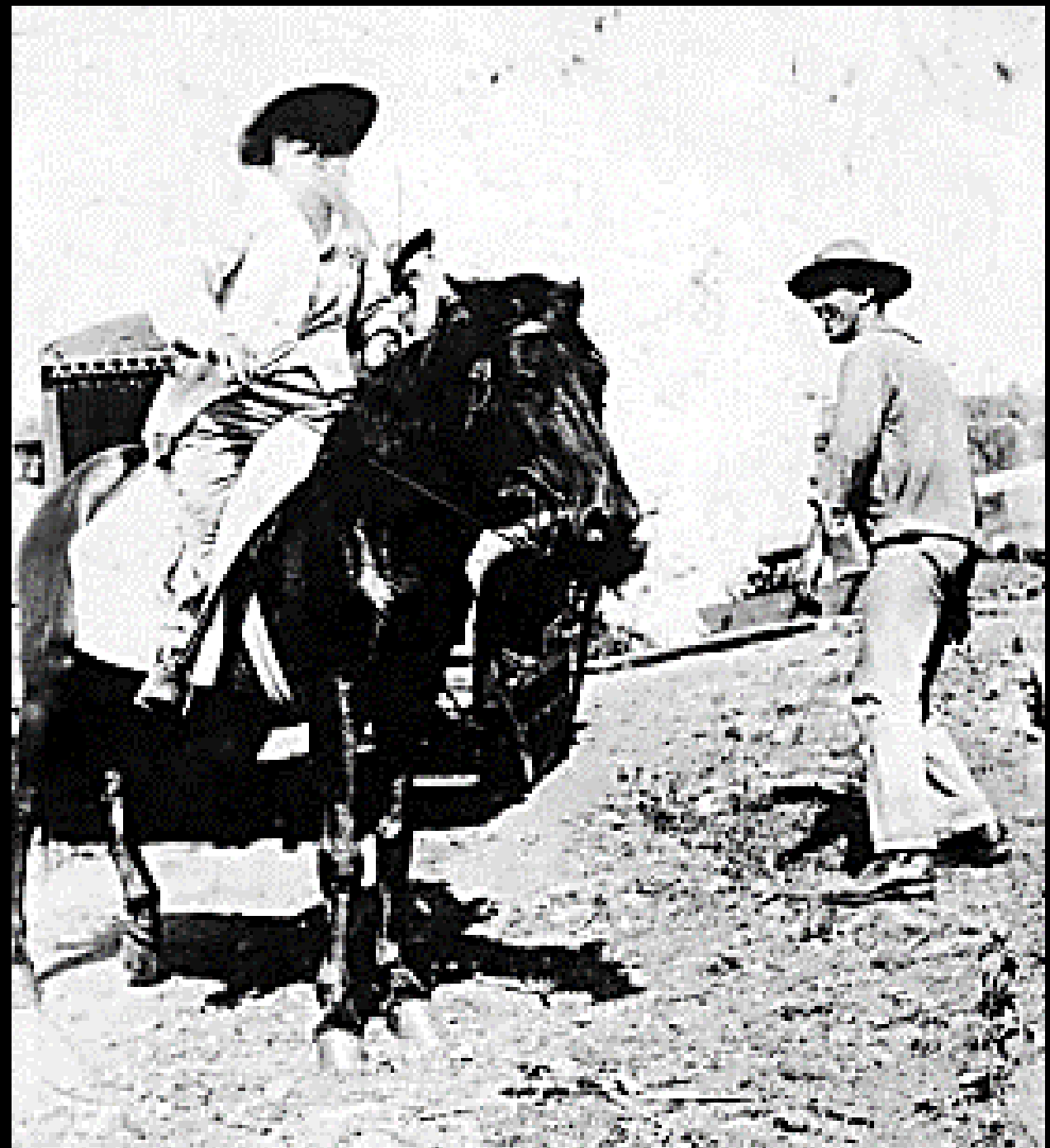

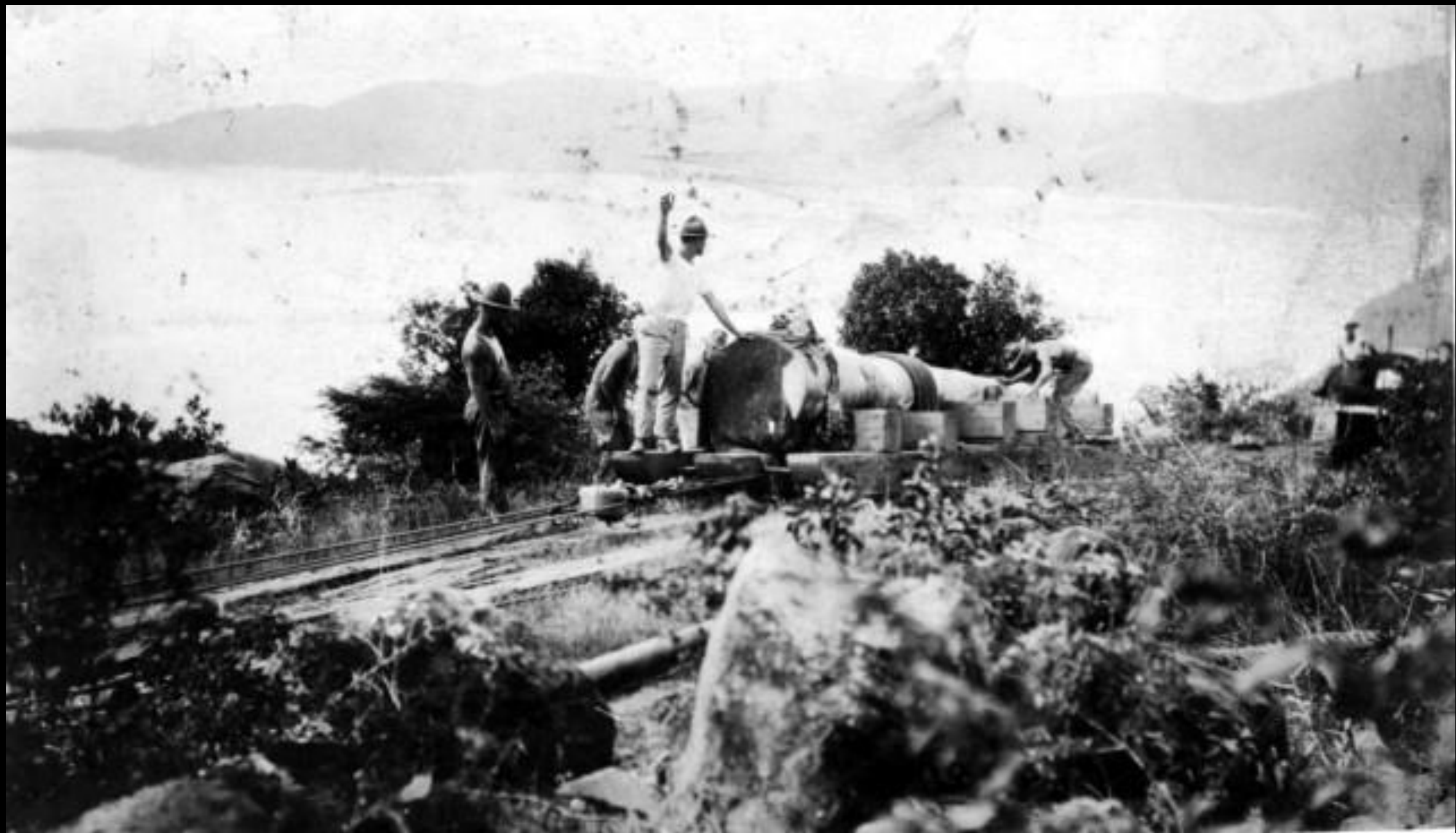

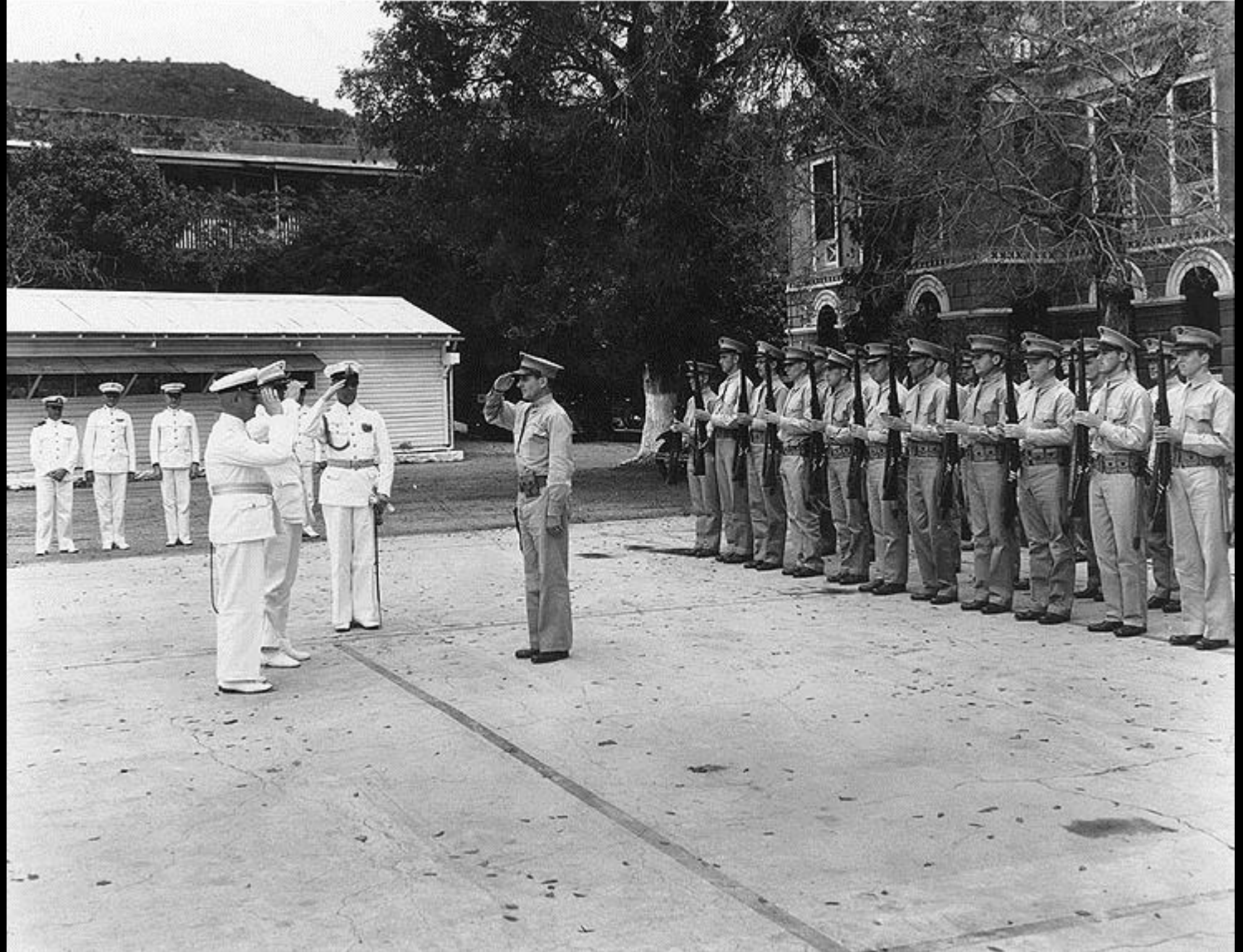

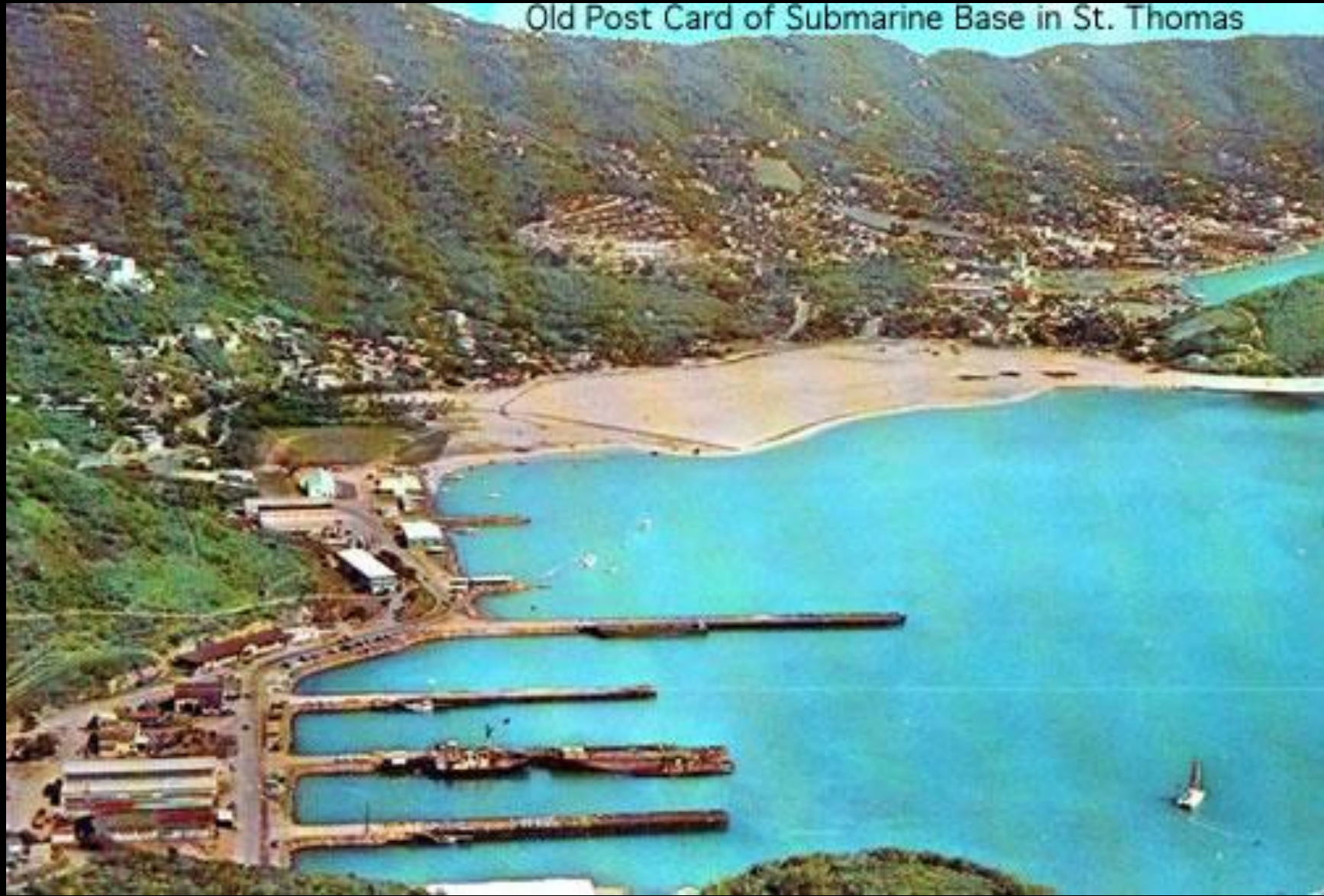

Bourne Field, St. Thomas

Bourne Field, comprised two 1600-foot sod-surfaced runways which were used by the Marines as an outlying training field; the radio station was a minor installation, and the submarine base had long since been abandoned as such.

The initial program called for improvements and additions to existing facilities to accommodate a Marine squadron of 18 planes on a permanent basis and a waterfront development to serve one patrol-plane squadron in a tender-based status.

The main east-west runway at Bourne Field was extended to a length of 4800 feet, and a 100-foot extension was added to the steel hangar, together with additional quarters, an administration building, additional gasoline storage, a cold-storage building and commissary, extensions to roads and services, and a new 60-bed dispensary and hospital. A concrete ramp, hangar, and utility shop were also built to accommodate seaplane operations in Lindbergh Bay.

Fifty low-cost housing units were added to the contract during October.



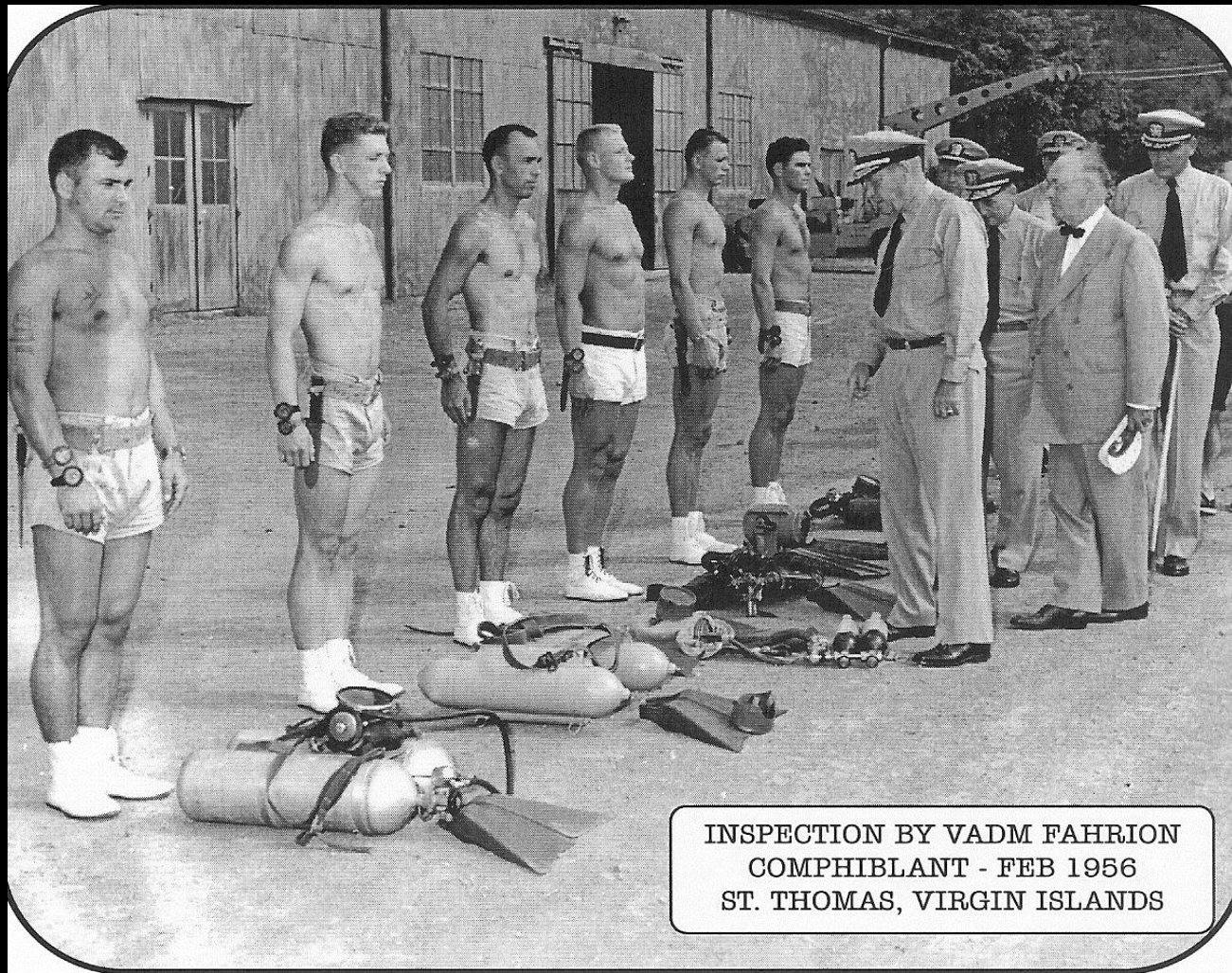
Sub Base: UDT training facility

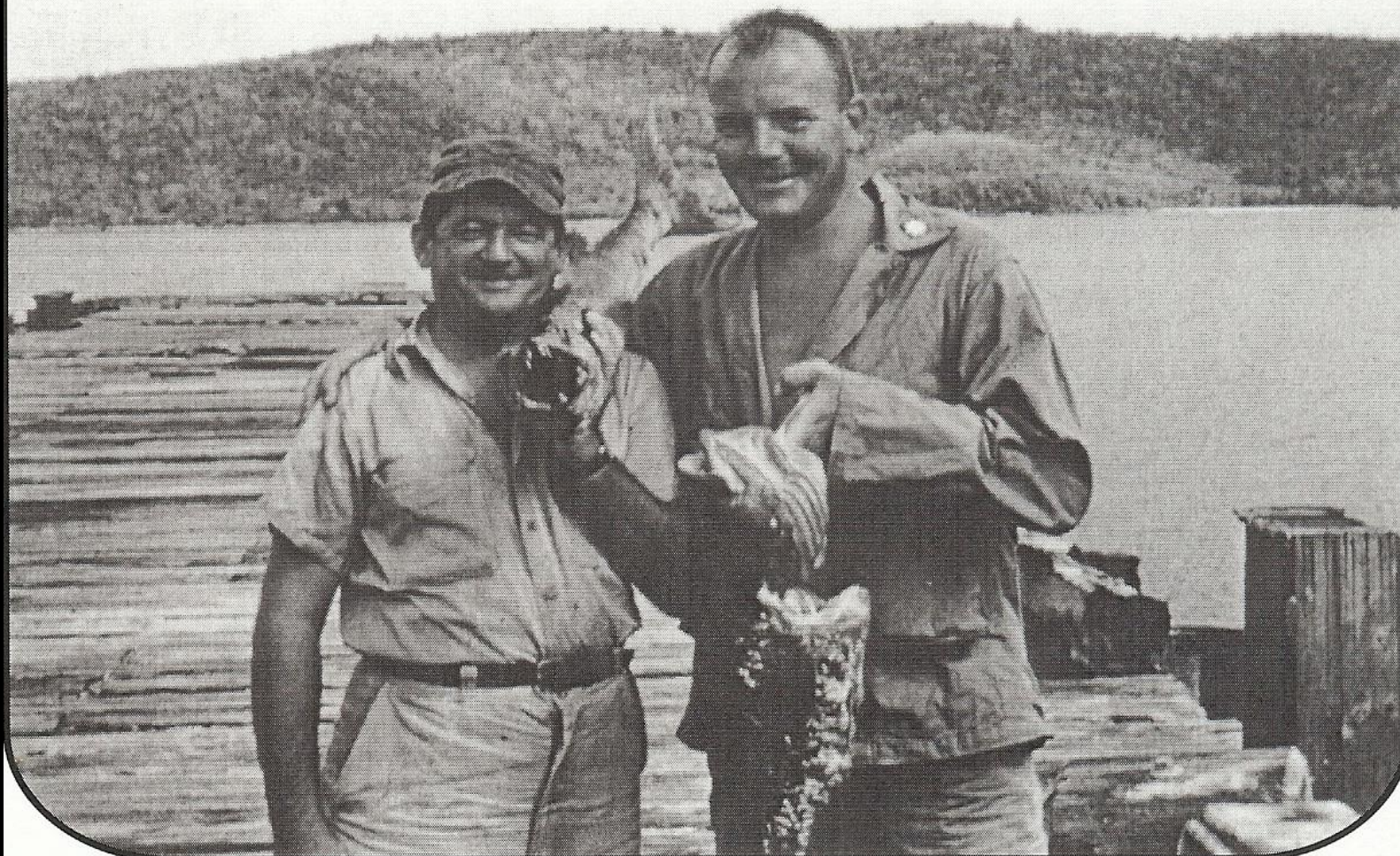

MEMORANDUM

Subj: Report of Offenses under the Uniform Code of Military Justice


1. I wish to report certain offenses which I feel are violations of Articles 112, 133, and 134 of the Uniform Code of Military Justice, committed by the following officers:

LTJG John T. DONOHUE, 581488, USN, UDT 21
LTJG John J. CONNELLY, 574489, USN, UDT 22
LTJG Norman H. OLSON, 508961, USN, UDT 21
LTJG Robert S. MATTESON, 574952, USN, UDT 21
LTJG Norman K. OTT, 585582, USN, UDT 22
ENS. Arthur L. ANDREW, 519677, USN, UDT 21

2. Between the hours 2015R and 0330R on the night of 10 - 11 December 1955, at the Naval Air Station, Quonset Point, Rhode Island, while in a duty status awaiting air transportation from Quonset Point to Norfolk, Virginia, the above officers drank excessive quantities of alcoholic beverages. They were uncooperative and unresponsive to the requests and orders of the Officer in Charge of the group to which they were attached. Their condition was manifest to a large group of enlisted men attached to UDT 21 and UDT 22. Their condition and that of other personnel of the detachment raised serious doubts in the mind of the pilot whether the group was fit to travel by air. LTJG DONOHUE and LTJG CONNELLY were the most serious offenders, having drunk such excessive quantities of intoxicating liquor that they were incapable of caring for themselves during any emergency which might have occurred during flight and incapable of assuming the responsibilities commensurate with their rank should the need have arisen.
